We actually don't have between them but we do have declarations from J.Assange mouth talking about all these things where he even says about his extradition (theme) negotiations between USA/ECU

C) About when and where we can arrange this meeting.
We could make this happen in Alicante (Mediterranean Sea) there are way flights from Icelan to Oslo (Norway) to Alicante mostly daily we could pick you up from the Airport or if you have another city ming in

Spain we could do that as well.
The amount of materialwe have is huge my advice if would be great if you could come and see it with your own eyes so you can leave the doubt.

You also asked me who else is interested about this material.
We have made some conversations with press, channels from USA/UK Venezuelan people from Maduro President, but they want part of it and we are looking for someone who might want to buy it all if its possible.

I hope this helped you to understand and answered the questions you asked.

You are telling me that you are going to post a "promotional" video online. What is that for? I thought we where in negotiations. Why is this necessary? It seems to indicate that we are not exchanging in good faith.

Dear Kristinn,

I do not know if I am addressing the extraordinary person we met on Tuesday, April 2, 2019 in Madrid, or Mr. Kristinn yesterday afternoon who we saw confused, nervous and stunned in the presence of his lawyer Aitor Martinez. In this regard, I would like to make some observations to avoid any possible confusion between you and us:

1.- Our research team (ten people) have achieved what Aitor Martínez has not achieved in ten years. We noticed a lot of aggression on his part yesterday, you even saw that we handle the matter of Julian Assange well, whom, at the moment, we only want to help. And I say at the moment because what happened after the meeting was very serious and generated debate within our team, where there are many who want to publish everything.

2.- At the meeting, the lawyer was interested in talking about the money and the papers that have been registered when he was at the Embassy of Ecuador in London. You and I have had at any time minimum, maximum, or simply some amounts? Not only we have not spoken or a text card, but we are willing to give it for free if necessary. We are professional journalists and very serious. But yesterday we saw that the lawyer Aitor Martínez destroyed any possibility of helping with our Julian Assange, it was very disappointing.

3.- Aitor Martínez proved to be a terrible lawyer. Yesterday he managed a material that is worth "gold" with kicks. If he would have been my lawyer I would renounce his defense immediately. So that it can be humiliating with its prestige, there are external people who can contribute material of great value. And at that juncture, they kicked us. You have the best lawyer in Madrid in a case that requires seriousness and astuteness. That boy yesterday proved to be very weak, almost primary school.

4.- Kristin, we have much more material. We will not allow once again that when we get to the train station in Madrid fret with you, the national police would come to ask for our personal documentation to those of us who are with you, in addition to photographing our identity documents and sending them by WhatsApp. criminal act. And it is also normal that upon arrival in Alicante, two cars chased us through the streets of the city for an hour, until they end up in the police station to lodge most of the complaint, we denounce that today they go to the courts for alleged rights of persecution, freedom of expression, intimidation, attempted kidnapping, violence and other possible crimes. Registrations contrasted in the DGT as [REDACTED] vehicle that can not be identified by security protocol. (NATIONAL POLICE).

5.- Kristin, we could have published it in November, December, January, February, March and the real thing, but we decided not to do it to take better advantage of the time to get the freedom of Julian Assange. You are the only ones who have seen 2% of the material, and

before the deal yesterday, we are considering publishing it in a few days for the world. Yesterday Aitor speaks of moral, of not taking advantage of the state of Julian, so that he does not show the light of his state of health and other things, nevertheless, presumably of being one of the lawyers incapable to do anything positive to free J.A. They criticize us about this, and yet we are talking about a man who published the murder of innocent children in a war with unscrupulous documents.

6.- Yesterday we offered your lawyer Aitor Martínez the following question: "What do you need? We got it for you. " And this man, with a management of all the documents and the help given, is still in a line of defense that looks disastrous for Julian. Your lawyer seems very interested in the case. Julian Assange a long time ago, and this form of prominence and good bills that are made to do nothing. The results are shown on the next page.

7.- If you still have an interest in the pressure from the Ecuadorian government of Julián according to the latest news from yesterday and today, please contact our phone or email. If you want to meet us, we will be in Alicante attending our Law Firm, and acting in a professional manner.

8.- I remind you that you and us have not had any money at any time.

9.- Julian is at the limit of his resistance to the latest information. Here you have a chance to save yourself from the worst because of the words of the president of Ecuador, Mr. Lenin, yesterday.

10.- Are you interested in knowing if there is something in the documents that "you are interested in knowing if you are or not?"

For all.

I expect maximum professionalism on both sides. And I beg you to tell your lawyer Aitor Martínez to stop playing like children with coercion, pressure, attempts to torture our mouths so that we do not say anything of what he himself has caused ... What he did yesterday is typical of a student of Law, which worries when his prestige is so high, we do not know if he has managed the race in a licit way or paying for it, as is fashionable in Spain, although seeing his mafia performance

We end in peace, as we said the first day in your apartment. We come> to help, not to receive humiliations and police controls, coercion. We are not going to let journalists want to cover our mouths, let alone> playing with the life of Julian Assange. All the material is very well collected with copy before a notary, in our law office so that everything is published in case any member of the team happens something, or is coerced again. We are not going to allow ourselves to be shut up in a mafia plan involving corrupt police officers who have already been denounced and to open a record in court along with a copy of part of all this documentation so that the appropriate measures are taken.

I am quite confused by your email. To start with, I called Aitor in as he is the representative of Julian Assange (JA) who wanted him involved. Aitor has power of attorney for JA - not me. And you mentioned that if not payed, you would publish the material in media. Later of course you talked about other possible "buyers" of the material.

It is true that I avoided talking about sums of money. I wanted first to see what you had. And I now know, more or less. The biggest story here is the fact that JA is a victim of massive spy operation by the Ecuadorian government, both unethical and illegal.

You mention that you might even consider to hand over this material, - without charge, in order to help Julian Assange. I think that is a welcoming sign of dramatic change of good will and I encourage that we consider this way. If you hand over the material to us, exclusively and without charge, I will hail [REDACTED] as a serious whistle blower who is committed in defending Julian Assange, against oppression form the Ecuadorian president, The US, UK and other powers. Or if you prefer, you will remain the anonymous source, as that is the usual WikiLeaks way.

I have no idea why policemen stopped you at the train station and asked for ID's. Why is that logical? Does this happen often? Could this be normal check? Are you and your friend in the police radar for something?

You and I, Pepe, are seasoned middle aged men who know life, unlike Aitor who is a young and ambitious hot-head. Before we enter into some mess of undesired results, we might want to talk how we settle this matter in the manner I propose.

We know the tension that exists between the government of Ecuador and J.A., with the eyes of the world press pending of London before the possible extradition in hours or days, something that worries us.

I want to make it very clear to you and also to Julian Assange that our action does not move exclusively for money, No. We want to participate in Julian's freedom without causing harm to anyone.

Of the ten people that make up our team, four ([REDACTED] and I) have voted to deliver all the documentation for free to show the world that the security of the Embassy of Ecuador in London DOES NOT EXIST, it is a lie . And to show that politicians cheat people every minute that goes by clock. Four of us have said that, but six people have said no, that so much effort and sacrifice must be rewarded in some way because we all live from our work, we are not rich people and we need to support our families.

I've convinced the whole team so nothing comes out. Not a photo, not a document, not a video. Absolutely nothing. We gave your word to you not to negotiate with any means of communication, and we will keep it.

Today, as you can understand, the contacts we had made urgently called to buy everything (Televisa, ZDF, LaSexta ...), and we said "NO". We are people of word. They have offered us a lot of money, but we have a

We want to help. You told us yesterday, Thursday, that you needed to know if there was anything specific in the documents. With total discretion you can tell me what it is about, I look at it and I answer, you can fully trust. We are adults and we know that at this time any decision can be very important for the life of J.A.

I am looking forward to your response. Count on us as allies, not as enemies. And the passage of time will show that despite having been able to publish everything since last year, we have come here without delivering anything to anyone or publishing anything, and that is for something. We are not gypsies or spies as lawyer Martinez came to intuit. We are very serious and very professional people committed to truth and freedom of expression.

I remain open to any proposal, but it must be concrete and leave it settled quickly.

First of all, we want to express our gratitude for your kind reply. We

actually understand the dramatic situation that has been experienced in recent days by all of us. Definitely, we have experienced with intensity and under much pressure the events of the Embassy of Ecuador

in London, especially after our meeting in Madrid with Aitor Martínez; since then, we are being controlled by the national police every day in our work and our homes, even they are notably chasing us.

Therefore, we have investigated the vehicles that have followed us, and it is confirmed that they are police cars. Hence, we want to strongly invite you to intercede and advise Aitor to stop chasing and coercing us, because if he continue with this behavior, we will have to take the corresponding legal measures. In a democratic country like

Spain that is unforgivable.

Regarding the material, as you can understand, we are receiving millionaire offers from those who once knew about its existence, nothing new. At present all of them have been rejected because our conversations are focused only you and J.A and we are serious and responsible people. We have once again had a meeting with the entire [REDACTED] team, and there are people who want to make their work profitable, and they want 1,500,000 euros free of taxes, payable by transfer, documented and legal. The operation would be carried out in the office of our lawyer in Alicante, where, of course, Aitor Martínez would be able to come or who you would like to.

It is our last offer for that research work that you have seen in Madrid. As you know four of the components of [REDACTED] we would be willing to deliver all the material free, but we have to respect the decision of the majority. That is why we have reduced he initial price.

However, we are open to a counteroffer on your part, which we would study immediately in a few hours. There is a television channel that offers a lot of money for everything at this moment, and yet, as we are demonstrating, we did not hand over to anything or anyone. Remember that we have had the material a long time ago and have kept everything discreet.

Perhaps a possibility to lower the price for everything would be to offer the team from you (WikiLeaks) the possibility of obtaining the exclusive [REDACTED] to write a book about the history of J.A. in the future, not now. It is something I propose if you think that is possible. It's an idea that we think can be attractive to all of them.

In that case we could reduce the amount too considerably.

Kristinn, it's time to make a final decision. This matter burns our hands and we must do something now, without losing more time. We are waiting for your response, with absolute confidence and hoping that in

hours, no later than Friday, we can reach an agreement between us. The conditions have already been exposed in this letter.
